

## **Website Privacy Statement of AVK GmbH**

This website is operated by **AVK GmbH**, company number (FN) 331849p, Theresiangasse 7/1/7, 1040 Vienna, Austria („we“ or „us“). This statement describes how we, as the accountable party with regards to data protection law, process your personal data in relation to this website.

### **1. Kinds of your personal data we process**

In the course of your visit to this website we will collect the following information: Date and time of accessing a page on our website, your IP address, name and version of your web browser, the website (URL) you visited before accessing this website, certain cookies (see item 2 below) and such information as you provide yourself by filling out the contact form or by signing up on our website.

There is no obligation to actually provide the data we ask you to provide on our website. However, if you refrain from doing so, you will not be able to use all functions of the website.

### **2. Cookies**

This website uses so-called cookies. A cookie is a small file which may be stored on your computer when you visit a website. Generally, cookies are used to provide users with additional functions on a website. For instance, they can be used to facilitate your navigation on a website, to allow you to resume using a website where you have previously left it and/or to store your preferences and settings when you revisit the website. Cookies can neither access, nor read, nor change other data on your computer.

Most cookies on this website are so-called session cookies. They are automatically deleted when you leave our website. Permanent cookies, however, remain on your computer until you manually delete them in your browser. We use such permanent cookies to recognize you when you revisit our website.

If you wish to control cookies on your computer, you can set your browser to notify you should a website intend to store cookies. You can also block or delete cookies when they have already been saved to your computer. If you want to know more about taking these steps, please use the „Help“ function in your browser.

Please mind that blocking or deleting cookies may interfere with your online experience and may prevent you from using this website at its fullest.

### **3. Purposes of data processing**

We will process your personal data for the following purposes:

- to provide you with this website and to further improve and develop this website;
- to present our online offers in an attractive way;
- to be able to obtain user statistics;
- to be able to detect, avert and investigate attacks on our website
- to reply to your requests (posed via e-mail or contact form)

#### **4. Legal basis of data processing**

The legal basis for the processing of your personal data is our overriding legitimate interest (pursuant to Art 6 para 1 point f EU General Data Protection Regulation) to achieve the purposes detailed in item 3 above.

#### **5. Transmission of your personal data**

To achieve the above-mentioned purposes, we will transmit your personal data to the following recipients:

- Data processors (e. g. IT service providers) employed by us.

Some of the above-mentioned recipients reside outside of your country or process your personal data there. The level of data protection in other countries may not be the same as in your country. However, we transmit your personal data only to countries with an adequate level of data protection (as determined by the EU commission), and we employ measures to ensure that all recipients have an adequate level of data protection. To this end we conclude, for instance, standardized contractual clauses (2010/87/EC and/or 2004/915/EC). These are available on request at [office@avkgroup.at](mailto:office@avkgroup.at).

#### **6. Duration of data storage**

We will store your personal data only for as long as we deem it reasonably necessary, in order to achieve the purposes detailed in item 3, and only to the extent as this is permissible by applicable law. In any case, we will store your personal data for as long as legal obligations to retain the data prescribe it, limitation periods for potential claims have not yet expired and/or for as long as it is necessary in order to investigate detected attacks on our website.

If you sign up to our website, we will in any case store your data for as long as your account exists, and thereafter only for as long as stipulated by legal obligations.

#### **7. Your rights in relation to personal data**

Under the conditions of applicable law, you have, among others, the right (i) to examine which of your personal data, if any, we have in storage and to receive copies of said data, (ii) to request the correction, supplementation or deletion of your personal data, in case they are false or are processed in a way not

conforming to the law, (iii) to request that we limit the processing of your personal data, (iv) to object, under certain circumstances, to the processing of your personal data or to withdraw the previously given consent to data processing, (v) to request data portability, (vi) to be informed about the identity of third parties to which your personal data are transmitted and (vii) file a complaint with the competent authority.
